## **Aikya Club Rules**

To provide a quality environment that will be clean, safe, and pleasant to all Members, the following guidelines must be adhered to when in the clubhouse or on Club property. These rules and regulations apply to all Members, dependents and guests of the Members. The Club reserves the right to modify the Club Rules from time to time.

- 1. The Club shall remain open from 7:00 AM to 10:00 PM on all days. Detailed list of timing for is available on a notice board near the entry to the Club. Management reserves the right to change the club open time.
- 2. Members are requested to sign the entry and register kept at the Club reception. Members are required to carry their membership card and produce it on demand.
- 3. The right of admission, however, is reserved to the Management, and the Management may also at any time without assigning any reason require withdrawal from the Club of any person admitted as a guest or nominee of the Member.
- 4. Management reserves the right to verify the identity of all persons entering the premises to ensure that only Members, their dependents or nominee and guests of such Members are admitted.
- 5. No political, religious, commercial or outside organization is permitted use of the Club facilities, even though a Member or his nominee is a member of the organization.
- 6. Club users are required to maintain decorum at all times.
- 7. Entry of any unauthorized person is not allowed inside the Club.
- 8. Entry of pets within the premises of the Club is strictly prohibited.
- 9. Smoking is permitted only in the designated areas as specified by the Management.
- 10. Chewing of Pan/Pan Masala or tobacco products, etc. are strictly prohibited in the Club.
- 11. Possession of firearms, ammunitions and weapons of any kind whether licensed or not within the Club premises is strictly prohibited.
- 12. No one shall bring food or drink from outside. Food and beverages will be supplied by the Club at rates as may be fixed from time to time by the Management. Catering by any outside agency not duly authorised by the Management within the Club premises is not permitted.
- 13. Users of the Club are not permitted to give any monetary or non-monetary benefits to any staff of the Club. A service charge will be added in the bills relating to food, soft beverages and other items.
- 14. Attire: Management has the right at its sole discretion to refuse entry to Members, their dependents and their guests who are not dressed appropriately.
- 15. Personal Property: The Club is not responsible for damage, loss, or theft of personal property. You should keep any valuables with you at all times while using the facilities. Storage areas do not always protect valuables.
- 16. Lost and Found: Lost items will be stored for 30 days before being discarded or donated to a local charity, Identify your lost items at the Club Management office.

- 17. Solicitation: No solicitation by Members, dependents, or guests is allowed in the clubhouse or on Club property unless approved by Club Management.
- 18. Management: Club Management may suspend or cancel the rights, privileges, or membership of any Member whose actions and/or actions of their dependents and guests are detrimental to Club or the enjoyment of the clubhouse or Club property by other Members or any conduct which in the opinion of Club Management is prejudicial to the welfare, good order and character of the Club or clubhouse. Any inappropriate behaviour, such as profanity or yelling that is incidental to the enjoyment of the clubhouse and facilities by others, may result in membership termination without a refund.
- 19. Amending of Rules: We reserve the right to change or add to these rules and adopt new ones, as we may feel necessary for proper management of the Club.
- 20. Access: Members, their families, nominees or guests, shall have access to the Club. Access control shall be as prescribed by the Management. No Member or their family or nominee or guests shall allow any unauthorised person to enter the Club or allow any person accompanying them to tamper with, deactivate, or attempt to circumvent the access control system employed by the Club.
- 21. Guest Policy: Members may invite guests to the Club. No more than six guests may be invited at any one time, and the same guest may not be invited more than four times during the month. Guests are allowed only when accompanied by the members. On special occasions when member wants to host dinner/ party in the club to larger gathering same has to be informed by email at least 48 hours prior to the event. If it is cocktail party then at least a week in advance to procure required excise permissions.
- 22. Unaccompanied Minors: Minors under 12 years of age must be accompanied by the member when in the Club or using Club facilities. Children below 12 years of age will not be allowed entry in the Club unless accompanied by an adult person admitted to the Club and is himself/herself entitled to use the Club facilities.
- 23. Restricted Use: Certain facilities within the Club are for restricted use during Club events. In the Club's sole and absolute discretion, use may be granted upon the Member's written request. Member may be responsible for posting a deposit and paying a reservation fee in accordance with the published rates promulgated by the Club.
- 24. Parking: No overnight parking will be allowed on Club property without the expressed written permission of Club.
- 25. Quiet Hours: Quiet hours for the Club shall be from 10:00 PM until 7:00 AM. No activities shall be undertaken in, on, or about Club property that disturb the neighbourhood's peace and tranquillity.
- 26. Events: Members shall be entitled to reserve any portion of the Club at the discretion of Club. Members reserving such portions of the Club shall be responsible for posting a cleaning deposit and paying any fees required by Club.
- 27. Organized Events: Club reserves the right to have specially organized events for its Members and the public at large. Such events shall be at the discretion of Club. Members shall be responsible for paying any applicable fees imposed by Club to participate in certain events that may require payment.

- 28. Conduct: Members, their families or nominees or guests shall at all times conduct themselves with due respect to other persons. Profane, aggressive, or hateful conduct or language will not be permitted. Any person who is intoxicated or engages in activities or speech that disrupts the peaceful use and enjoyment of the Club by others will be removed from the premises. Membership will be forfeited should any person be removed from the Club for such activities more than two times in any year.
- 29. Property Damage: Members, their families or nominees or guests shall be responsible for any damage to the Club or any property in or on Club property caused by any negligent acts or omission attributable to them directly or indirectly. Cleaning fees may be assessed to a Member at the sole discretion of Club.
- 30. Modification to Rules: Club reserves the right to modify, amend, supplement or replace its rules and regulations from time to time in the sole and absolute discretion of the Club. Members, their dependents, and guests shall adhere to all said rules and regulations as they are modified or amended.
- 31. Ambiguities: Any ambiguity in these rules and regulations shall be construed more favourably for welfare of the Club.
- 32. Suspension of Benefits: Any Member not in good standing; delinquent in payment of dues, or who has been found to have violated the rules and regulations of Club, as promulgated from time to time, shall be subject to having their Club benefits suspended or revoked at the discretion of Club and shall not be entitled to any reimbursement for fees paid or deposits posted with Club if any.
- 33. Alcohol and Intoxicants: Members, their dependents, and guests of the legal drinking age are entitled to consume alcoholic beverages at the Club on specified alcohol days notified by the club, provided that Members, dependents, nominees and guests do not drink alcoholic beverages to the extent that they become visibly intoxicated. No other intoxicants such as marijuana, prescription drugs, or other substances are permitted on Club property. No Member, dependent, nominee or guest shall operate any vehicle, motorcycle, golf cart, bicycle, or other means of transportation on Club property while intoxicated.
- 34. The Club does not accept any responsibility or liability whatsoever for the death, injury, or any other consequence thereof, arising for any reason whatsoever, to the Member, their family, nominee, or guests within the premises.
- 35. In case of any issues, any person may enter their suggestion/complaint in the register book at the entrance of the Club.
- 36. All users shall strictly comply with the rules and regulations governing the use of all Club facilities, including but not limited to the gymnasium, swimming pool, spa, sauna, card room, conference hall, banquet hall, and any other spaces within the Clubhouse.
